

New Family Child Care Orientation

A **family child care orientation** training is required for anyone planning to become a licensed Family Child Care Provider or Certified Assistant in a family child care home in Massachusetts. In order to become a licensed provider you must attend a potential provider meeting (PPM) at one of the Department of Early Education and Care's (EEC) regional offices or at a location offered by EEC before registering for an orientation. EEC's southeast office is in Taunton at 1 Washington Street. (next to the Save-A-Lot store) September & November PPM's will also take place in Hyannis but you must still register with EEC's regional office prior to attending. Call **508-828-5025** to get dates and pre-register for this free meeting. People planning to be Certified Assistants do not need to attend the potential provider meeting; they can register for the orientation immediately.

Remember to bring a copy of the Family Child Care Regulations with you when you attend the orientation. You will get the regulations when you attend the PPM. Assistants can ask to borrow a copy from the licensed FCC provider that you plan to assist. It can also be downloaded from EEC's website.
